The Federal Ministry for the Environment, Nature Conservation and Nuclear Safety (BMU) through the International Climate Initiative (IKI) is investing in Latin America's water security and climate adaptation.

Mexico City, December 2019. The International Climate Initiative (IKI), which is promoted by the Federal Ministry for the Environment, Nature Conservation and Nuclear Safety (BMU) by decision of the German Parliament, is joining the Latin American Water Funds Partnership as a new partner to promote water security in the region after the approval of a technical cooperation agreement that will benefit the Water Funds model.

IKI is a key element of Germany's climate financing and the funding commitments in the framework of the Convention on Biological Diversity. The Initiative places clear emphasis on climate change mitigation, adaption to the impacts of climate change and the protection of biological diversity. These efforts provide various co-benefits, particularly the improvement of living conditions in partner countries.

The Partnership strongly believes in the coordinated action of actors from different sectors as the best mechanism to encourage the transformation towards a water secure world. The Partnership itself is an example of collaboration across sectors and the adhesion of the International Climate Initiative (IKI) brings the expertise and commitment of the German Government showing how different sectors can and must work together to solve the great global challenges such as water security and climate change.

Additionally, IKI will strengthen the Water Funds to become a major engine for climate change adaptation to reduce water risks for major cities in Latin America. With their support Water Funds will work to mainstream ecosystem- based adaptation strategies in their work. Nature-based solutions as protection and restoration of natural habitats and implementation of best-agricultural practices contribute to ensure water flows regulation and reduce risks in face of climate change related events.

"Having the IKI initiative as part of the LAWFP represents how Water Funds are increasingly making a positive impact on how water is managed, and how cities can become more resilient to Climate Change through investments in nature-based solutions. It will also contribute to strengthening the Partnership's capacity to support Water Funds directly so they can deliver ecosystem based adaptation strategies at scale, while at the same time help trigger enabling conditions from the policy, corporate and financial perspective so the funds can be sustainable and achieve their targeted impact goals for nature and people" said Aurelio Ramos, GM Conservation and Innovation, Latin America, The Nature Conservancy.

Water Funds have proven to be effective organizations that design and enhance financial and governance mechanisms that unite public, private and civil society stakeholders, around a common goal to contribute to water security through sustainable watershed management and nature-based solutions.
